In exercise of the powers conferred by section 1(3) and 2 of the National Pensions (Amendment) Act, 2020, the Cabinet makes the following Order —

**Citation and commencement**

1. (1) This Order may be cited as the National Pensions (Amendment) Act, 2020 (Extension of Pension Holiday) (No. 2) Order, 2022.  
(2) This Order comes into force on 30th June, 2022.

**Extension of duration of the National Pensions (Amendment) Act, 2020**

2. Sections 1, 2, 4 and 6 of the *National Pensions (Amendment) Act, 2020* expire on 30th September, 2022.

**Extension of duration of Part 1A of the National Pensions (Amendment) Act, 2020 - suspension of pension contributions**

3. The pension holiday period under section 5A of the *National Pensions Act (2012 Revision)*, as amended by section 2 of the *National Pensions (Amendment) Act, 2020*, expires on 30th September, 2022.

**Repeal of the National Pensions (Amendment) Act, 2020 (Extension of Pension Holiday) Order, 2022**

4. The *National Pensions (Amendment) Act, 2020 (Extension of Pension Holiday) Order, 2022* is repealed.
